BY-LAW NO. 88-118

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS 2 THIRD STREET, AS BEING OF ARCHITECTURAL AND/OR HISTORICAL VALUE OR INTEREST

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1980, Chapter 337, authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and

WHEREAS the Council of The Corporation of the Town of Grimsby has caused to be served on the owners of the lands and premises known municipally as 2 Third Street, and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

WHEREAS the reasons for designation are set out in Schedule 'B' hereto; and

WHEREAS no notice of objection to the proposed designation has been served on the Town Administrator of the municipality; and

THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF GRIMSBY ENACTS AS FOLLOWS:-

- There is designated as being of architectural and/or historical value or interest the real property known municipally as 2 Third Street, more particularly described in Schedule 'A' attached hereto.
- 2. The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule 'A' attached hereto in the proper land registry office.
- The Town Administrator is hereby authorized to cause a copy of this by-law to be served on the owner of the aforementioned property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

#### SCHEDULE 'B'

### 2 THIRD STREET, GRIMSBY

Two Third Street is a typical example of the old gingerbread cottages, with board and batten siding using the balloon framing technique. The house was constructed in the late 1800's, facing Bell Park in the historical 'Grimsby Park Area'.

The Grimsby Park Area has a rich history. It began in 1846 as a Methodist Camp Meeting Ground, and in 1878 the Boy's Tabernacle was built in the area. Grimsby Park became known as Grimsby Beach in approximately 1913, and grew into one of the most popular tourist spots in Ontario. Thousands of tourists from throughout Ontario and the United States visited Grimsby Beach annually, with many successful people spending their summers in the cottages near the beach. Two Third Street remains as one of the better examples of the Grimsby Park Cottages from the late 1800's, which is an important component in the history of the Town of Grimsby.
