### PRE-AUTHORIZED PAYMENTS

**Pre-Authorized Payment Plans** are the most convenient, worry free payment option to ensure that your taxes are paid on time with no risk of penalty or interest.

**Two plans are available:**

- **Monthly** - on the 15th of the month for 10 months from January to October or
- **Installments** - withdrawing payments on the regular installment due dates

### OTHER PAYMENT OPTIONS

- Online – at most financial institutions or by telephone and internet banking.
- Cheque - by mail or drop box (cheques only) at the front entrance of Town Hall. Address cheque to the “Town of Grimsby” include your tax stub and note your roll number on the memo line of the cheque.
- Post-Dated Cheques for Installments are accepted – however, Installment Pre-authorized Payment plans are a better option, requiring only one-time enrollment.
- Credit Card payments - see our website for more information. Administration fee applies.
- In Person – payments by debit, cash or cheque at Town Hall, 8:30 am to 4:30 pm

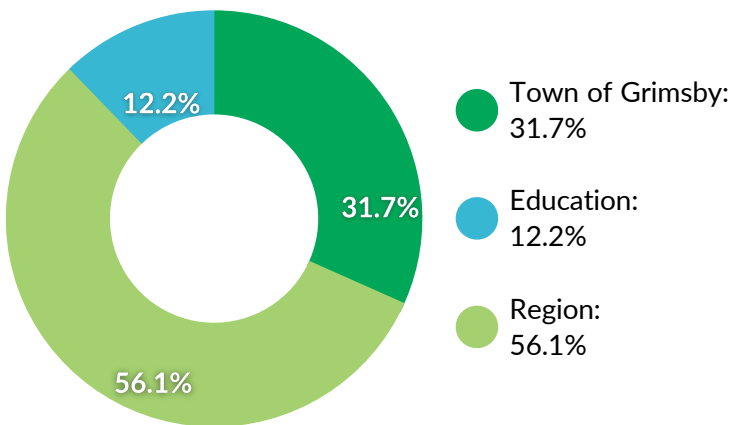
### PAYING ON TIME

Payments made online can take up to 3-5 business day to reach us. Keep this in mind when planning your online payment to be sure that your payment is received by the due date.

Penalties cannot be waived. Failure to receive a bill does not excuse the non-payment of taxes.

### WASTEWATER BILLING CHANGE

Prior to 2023, costs to maintain the Town’s wastewater collection system was fully funded by a wastewater levy on the tax bill. Council approved a budget change for 2023 forward. Wastewater costs will be divided between a levy on the tax bill and as a fee on your water bill.

- For 2023 - 66.7% Levy, 33.3% Water Bill
- For 2024 - 50% Levy, 50% Water Bill

This change results in a more equal distribution of wastewater costs by linking cost to consumption. Property owners will see a reduction on their tax bill. Try our online calculator to determine what impacts will be based on your property assessment and estimated water bill.

## NEW TRANSIT LEVY

On January 1, 2023 local transit services across the region amalgamated to create Niagara Region Transit, a single transit system that will improve connectivity between our communities and make it easier for people to get where they need to go. Regional Transit was previously included in both the Town of Grimsby and Niagara Region tax rate, but it's now billed separately as levy item on your tax bill.
