



**NOTICE OF ADOPTION
OFFICIAL PLAN AMENDMENT NO. 13
THE CORPORATION OF THE TOWN OF GRIMSBY**

TAKE NOTICE that on **July 4, 2023**, the Council of the Corporation of the Town of Grimsby passed By-law 23-60 to adopt Official Plan Amendment No. 13 to the Town of Grimsby Official Plan, pursuant to Section 17 of the *Planning Act*, RSO, 1990.

THE PURPOSE AND EFFECT of Official Plan Amendment No. 13 is to amend Schedules B, B-1 & B-2 by changing the designation of the subject lands at 41 Livingston Avenue from Low Density Residential Area to Medium Density Residential Area, and to amend Section 3.4.3 by adding a "Facility for Specialized Housing Needs at 41 Livingston Avenue" as a permitted use in Section 3.4.3.1.

OTHER RELATED PLANNING APPLICATIONS: Zoning By-law Amendment (File Number: 26Z-16-2204), By-law No. 23-61, approved concurrently by Council on July 4, 2023.

PUBLIC COMMENTS, as summarized in the Planning Staff Reports PA23-22 were considered as part of the decision making process.

Official Plan Amendment No. 13 is exempt from approval by the Regional Municipality of Niagara.

THE DECISION OF THE COUNCIL OF THE CORPORATION OF THE TOWN OF GRIMSBY IS FINAL IF A NOTICE OF APPEAL IS NOT RECEIVED ON OR BEFORE THE LAST DAY FOR FILING A NOTICE OF APPEAL.

IF YOU WISH TO APPEAL to the Ontario Land Tribunal a copy of an appeal form is available from the OLT website at <https://olt.gov.on.ca/appeals-process/forms/>

Only individuals, corporations or public bodies may appeal a decision of the municipality or planning board to the Ontario Land Tribunal. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of the appeal unless, before the plan was adopted, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

- ii) Set out the reasons for the appeal, and the specific part of the proposed Official Plan Amendment to which the appeal applies.
- iii) Be accompanied by the fee required by the Ontario Land Tribunal being \$1,100.00 (corporate fee) or \$400 (private citizen, registered charity, or non-profit ratepayers' associated) payable to the Ontario Minister of Finance.
