The Corporation of the Town of Grimsby

By-Law No. 16-82

A By-Law to regulate stopping, standing and parking of vehicles and to establish a system for Administrative Penalties

Enact as follows:

Part I

1.01 Short Title

1.01.01 This by-law may be referred to as the Parking and Administrative By-law;

1.02 Definitions for the purpose of this By-law:

- 1.02.01 "administrative fee" means any fee specified in the by-law and listed in Schedule "C".·'
- 1.02.02 "administrative penalty" means a monetary penalty as set out in Schedules "A" and "B".'
- 1.02.03 "area municipality" has the same meaning as in The Regional Municipality of Niagara Act, R.S.O. 1980, c.438 as amended;
- 1.02.04 "authorized emergency vehicle" includes fire department vehicles and equipment;
- 1.02.05 "authorized sign" means any sign or roadway curb or sidewalk parking or other device placed on erected on a highway under the authority of this By-law or Highway Traffic Act for the purpose of regulation, warning or guiding traffic or for the purpose of designating parking spaces for the sole use of physically disabled persons;
- 1.02.06 "bicycle" has the same meaning as in The Highway Traffic Act.'
- 1.02.07 "bicycle lane" means all parts of the highway save and except any roadway, shoulder, driveway or sidewalk and:
- 1.02.08 "boulevard" means all parts of the highway save and except any roadway, shoulder, driveway or sidewalk and

(a) "outer boulevard" means such portions of the highway lying between any sidewalk and the roadway or the shoulder where such exists;

(b) "inner boulevard" means such portion of the highway lying between the lateral boundary and the sidewalk and where there is no sidewalk it means that portion of the highway lying between the lateral boundary and the roadway or the shoulder where such exists;

- 1.02.09 "bus" has the same meaning as in The Highway Traffic Act;
- 1.02.10 "bus stop" means a portion of a highway designated as an area at which buses will stop receive or discharge passengers;
- 1.02.11 at which buses will stop receive or discharge passengers;
- 1.02.12 "Chief' or "Chief of Police" means the Chief of the Fire Department of the Town of Grimsby or the Chief of The Niagara a Regional Police Force;
- 1.02.13 "commercial motor vehicle" has the same meaning as in The Highway Traffic Act;
- 1.02.14 "comer" with reference to a highway intersection, means the point of intersection of the prolongation of the lateral curb lines or in the absence of curbs the prolongation of the edges of the roadways;
- 1.02.15 "crosswalk" has the same meaning as in The Highway Traffic
- 1.02.16 "cul-de-sac" means a highway which is closed at one end where a turning circle or basin is constructed to allow a vehicle to turn around and egress at the open end;
- 1.02.17 "day" means calendar day;
- 1.02.18 "designated by-law" means a by-law or provision of a by-law that is designated under this or any other by-law, as a by-law or provision of a by-law which this by-law applies and is listed in Schedules "A", "B", "C";
- 1.02.19 "designated parking space" shall mean a parking space marked by an authorized sign indicating such space to be for the sole use of a vehicle bearing a permit issued to a physically disabled person by the Province of Ontario pursuant to the Highway Traffic Act and the regulations made thereunder;
- 1.02.20 "designated school crossing" means a crosswalk which is established and specifically designated by signs to facilitate the crossing of a highway by school children under supervision of a school crossing guard;
- 1.02.21 "Director of Planning and Building Services" means the Director of Planning and Building Services or his or her designate;
- 1.02.22 "Director of Public Works" means the Director of Public Works of The Town of Grimsby or his or her designate;
- 1.02.23 "driveway" means the improved land on a highway which provides vehicular access from the roadway to a laneway or parking area on adjacent land;
- 1.02.24 "emergency vehicle" has the same meaning as in The Highway Traffic Act;
- 1.02.25 "extension period" means a time period from time to time established by the Director of Planning and Building Services and set down in a

Corporate Policy.

- 1.02.26 "farm tractor" has the same meaning as m The Highway Traffic Act;
- 1.02.27 "fee" means an Administrative Fee from time to time established by Council and listed in Schedule "C"
- 1.02.28 "fire department vehicle" means a vehicle actually used on Fire Department business and includes any private passenger vehicle or other vehicle operated by a fire fighter for the purpose of attending to his or her duties;
- 1.02.29 "fire route" means an access or egress route providing access to and egress from buildings or structures for the purpose of preventing fires or spread of fires. The surface of such route shall be of a suitable hard, dust-free material acceptable to the Chief;
- 1.02.30 "gross weight" has the same meaning as m The Highway Traffic Act;
- 1.02.31 "The H.T.A." or "The Highway Traffic Act" means The Highway Traffic Act 1990, c. H.8, as amended;
- 1.02.32 "Hearing Decision" means a notice that contains the decision of a Hearing Officer;
- 1.02.33 "Hearing Non-Appearance Fee" means an Administrative Fee from time to time established by Council in respect of a Person's failure to appear at the time and place scheduled for a review before a Hearing Officer and listed in Schedule "C";
- 1.02.34 "Hearing Officer" means each person appointed from time to time by Council;
- 1.02.35 "heavy vehicle" means any commercial motor vehicle having an unloaded vehicle weight in excess of four thousand five hundred (4,500) kilograms (9,925 lbs.) but does not include ambulance, fire apparatus, vehicles owned by or operated for the Town of Grimsby, Regional Municipality of Niagara or the Ministry of Transportation;
- 1.02.36 "highway" has the same meaning as in The Highway Traffic Act;
- 1.02.37 "holiday" includes Sunday, New Year's Day, Good Friday, Easter Monday, Victoria Day, Canada Day, the day proclaimed as a Civic Holiday, Labour Day, Thanksgiving Day, Remembrance Day, Christmas Day, Boxing Day, the day proclaimed as the Monarch's birthday or the day fixed by proclamation of the Governor General or Lieutenant-Governor-in-Council as a public holiday or for a general feast of thanksgiving and the next following day when any such holiday falls on a Sunday;
- 1.02.38 "intersection" has the same meaning as in The Highway Traffic Act;
- 1.02.39 "island" means a portion of a highway so constructed as to separate or direct vehicular traffic onto specific portions of the roadway, or provided for the use or protection of pedestrians;
- 1.02.40 "laneway" means improved land adjacent to the highway that provides

access from the highway to a parking area on the adjacent land;

- 1.02.41 "late payment fee" means an Administrative Fee from time to time established by Council in respect of a Person's failure to pay an Administrative Penalty within the time prescribed in this by-law and listed in Schedule "C".'
- 1.02.42 "law enforcement officer" shall mean the By-law Enforcement Officer of the Town of Grimsby or any other officer authorized to enforce this or any other by-law of the Town or a constable or Police Officer appointed for the enforcement of the provisions of the Highway Traffic Act;
- 1.02.43 "loading zone" means the portion of a roadway set apart for the exclusive purpose of parking a commercial motor vehicle to load or unload the same;
- 1.02.44 "MTO search fee" means an Administrative Fee from time to time established by Council in respect of searching the records of the Ontario Ministry of Transportation and listed in Schedule "C";
- 1.02.45 "median strip" has the same meaning as m The Highway Traffic Act
- 1.02.46 "Ministry" means the Ministry of Transportation of Ontario;
- 1.02.47 "mobile canteen" includes any vehicle in or from which any food or other edible substance or any beverage offered for retail sale or sold direct to the consumer;
- 1.02.48 "motor assisted bicycle" has the same meaning as m The Highway Traffic Act;
- 1.02.49 "motorcycle" has the same meaning as in The Highway Traffic Act;
- 1.02.50 "motor vehicle" has the same meaning as in The Highway Traffic Act;
- 1.02.51 "municipal property" means any open area or portion of a structure other than a street or highway, intended for the temporary parking of vehicles and on which there is "designated parking spaces";
- 1.02.52 "municipal parking lot" means land or structures which have been set apart, designated or established by the Town for the parking of motor vehicles;
- 1.02.53 "municipality" means the Corporation of the Town of Grimsby;
- 1.02.54 "NSF fee" means an Administrative Fee from time to time established by Council in respect of a demand for payment received by the Town of Grimsby from a Person for payment of any Administrative Penalty or Administrative Fee, which has insufficient funds available in the account on which the instrument was drawn;
- 1.02.55 "officer" means a police officer, municipal law enforcement officer or any other person authorized to enforce the Highway Traffic Act;
- 1.02.56 "official sign" has the same meaning as in The Highway Traffic Act or means any sign or other device placed or erected on a highway under the authority of this by-law for the purpose of regulating, warning or

guiding traffic;

- 1.02.57 "one-way roadway" means a roadway or part of a roadway designated as such by by-law of the Town;
- 1.02.58 "oversized vehicle" means any motor vehicle having permanently attached thereto a truck or delivery body and having a gross weight, as registered in the Ministry, in excess of 3,600 kg and includes tractors used for hauling purposes on the highway, buses, motorized and mobile homes, trailers and portable offices;
- 1.02.59 "owner" means the registered owner of a motor vehicle as provided by the Ministry of Transportation of Ontario (MTO);
- 1.02.60 "park" or "parking" has the same meaning as in The Highway Traffic Act;
- 1.02.61 "parking meter" means a device that shall indicate thereon the length of time during which a vehicle may be parked which shall have as a part thereof a receptacle for receiving and storing coins, a slot or place in which such coins may be deposited, a timing mechanism to indicate the passage of the interval of time during which the parking is permissible and which shall also display a signal when said interval of time shall have elapsed.
- 1.02.62 "parking meter zone" means the highways or parts of highways designated by this by-law as constituting a parking meter zone.
- 1.02.63 "parking space" means a portion of the surface of a highway designated by suitable markings, the use of which is controlled and regulated by a parking meter.
- 1.02.64 "pedestrian" means a person on foot, or in a wheelchair, baby carriage, or on a child's play vehicle propelled by muscular power;
- 1.02.65 "pedestrian barrier" means a rail, fence or a device installed on a sidewalk or at any location within a highway where pedestrian is prevented from crossing the roadway or entering a barricaded area;
- 1.02.66 "pedestrian crossover" has the same meaning as in The Highway Traffic Act;
- 1.02.67 "penalty notice" means a notice given pursuant to Schedule "A" of this by-law;
- 1.02.68 "penalty notice date" means the date specified on the Penalty Notice pursuant to Schedule "A" of this by-law;
- 1.02.69 "penalty notice number" means the reference number specified on the penalty notice that is unique to that penalty notice pursuant to Schedule "A" of this by-law;
- 1.02.70 "permit" shall mean a permit issued to a physically disabled person for a period not exceeding five years by the Province of Ontario pursuant to the provisions of the Highway Traffic Act and the regulations made thereunder;

- 1.02.71 "person" includes a corporation, partnership or limited partnership;
- 1.02.72 "physically disabled person" shall mean a person who is physically disabled in such a way that his or her mobility is seriously restricted, including, among others, a person who uses a wheelchair, crutches, braces or other mobility-assisting devices;
- 1.02.73 "Police Force" means The Niagara Regional Police Force;
- 1.02.74 "Police Officer" means a constable, any municipal by-law enforcement officer or any person appointed for enforcing or carrying out the provisions of this by-law;
- 1.02.75 "public parking facility" shall mean a parking lot or other parking facilities on private property or on property owned or occupied by the Town or any local board thereof, to which the public has access, whether on payment of a fee or otherwise;
- 1.02.76 "public vehicle" has the same meaning as in The Highway Traffic Act;
- 1.02.77 "Regional Municipality" or "Region" means the Corporations of the Regional Municipality of Niagara;
- 1.02.78 "Request for review by Hearing Officer" means the form attached to the screening which may be filed by a Person pursuant to Schedule "A" of this by-law;
- 1.02.79 "Request for Screening" means request delivered in accordance with #5 of Schedule "A" of this by-law and within the time limits set forth in #5 of Schedule "A" of this by-law;
- 1.02.80 "Regulation" means the Administrative Penalties, Ontario Regulation 333/07;
- 1.02.81 "roadway" has the same meaning as in The Highway Traffic Act;
- 1.02.82 "route" means a private roadway;
- 1.02.83 "school bus" has the same meaning as in The Highway Traffic Act;
- 1.02.84 "screening decision" means a notice that contains the decision of a Screening Officer;
- 1.02.85 "screening non-appearance fee" means an Administrative fee from time to time established by Council in respect of a Person's failure to appear at the time and place scheduled for a review by Screening Officer and listed in Schedule "C";
- 1.02.86 "Screening Officer" means a person appointed from time to time by Council;
- 1.02.87 "shoulder" means that portion of the highway lying adjacent to the roadway where there is no barrier curb and which is improved or maintained to support a stopped vehicle;
- 1.02.88 "side, approach" means that side closest to lawfully approaching vehicular traffic;
- 1.02.89 "side, remote" means that side most distant from lawfully approaching vehicular traffic;

- 1.02.90 "sidewalk" means a foot path or any portion of a highway set aside or improved for the use of pedestrians;
- 1.02.91 "social event" shall include, but not limited to, parades, street parties and other social, recreational, community, commercial or athletic activities;
- 1.02.92 "stand" or "standing" has the same meaning as in The Highway Traffic Act;
- 1.02.93 "stop" or stopping" has the same meaning as in The Highway Traffic Act;
- 1.02.94 "taxi cab" has the same meaning as in The Public Vehicles Act, R.S.O. 1980, c.425 as amended;
- 1.02.95 "Town" means The Corporation of the Town of Grimsby;
- 1.02.96 "Town Council" means the Council of The Corporation of the Town of Grimsby;
- 1.02.97 "traffic" includes pedestrians, ridden, led or herded animals, vehicles, motorized snow vehicles and other conveyances, either singly or together while using any portion of a highway for the purposes of travel or movement of goods;
- 1.02.98 "traffic control device" means any sign, traffic signal or other roadway, curb or sidewalk marking, or any other device erected or placed under the authority of this by-law for the purpose of regulating, warning or guiding traffic;
- 1.02.99 "traffic signal" means any device operated manually, electrically or mechanically for the regulation of traffic;
- 1.02.100 "Traffic Co-Ordinator "means the Director of Public Works of The Town of Grimsby;
- 1.02.101 "trailer" has the same meaning as in The Highway Traffic Act;
- 1.02.102 "Transit Commission" means any local board operating a public passenger transportation system or any private body operating a public passenger transportation system under franchise from or agreement with the Town;
- 1.02.103 "unauthorized motor vehicle" is a vehicle that does not have affixed thereto current identification issued and displayed in accordance with the provision of this by-law;
- 1.02.104 "U-Tum" means to tum a vehicle within a roadway in order to proceed in the opposite direction from the direction the vehicle was previously travelling;
- 1.02.105 "vehicle" has the same meaning as in The Highway Traffic
- 1.02.106 "wheelchair" has the same meaning as in The Highway Traffic

1.03 Interpretation

- 1.03.01 For the purpose of this by-law, unless the context requires otherwise:
 - (a) Words importing the singular number of the masculine gender only include more persons, parties or things of the same kind than one and females as well as males.
 - (b) A word interpreted in the singular number has a corresponding meaning when used in the plural.
- 1.03.02 Where words and phrases used in this by-law are defined in the Highway Traffic Act, but not defined in this by-law, the definitions in the Highway Traffic Act shall apply to such words and phrases.
- 1.03.03 Where there is conflict between the provisions of this by-law and the provisions of the Highway Traffic Act, the provisions of the Highway Traffic Act shall prevail
- 1.03.04 In the schedules to this by-law, the following abbreviations, definitions and symbols stand for the words respectively set forth opposite thereto as follows:

 - Blvd. Boulevard
 - Cir. Circle
 - Ct. Court
 - Cres. Crescent
 - Dr. Drive
 - Hwy. Highway

Distance

- 1.03.05 Where a distance is used in this by-law as from, to or within a specified distance of an object, structure, land, intersection or part of a highway, such distance shall be measured along the curb or edge of the roadway, from a point in such curb or edge of roadway opposite such objects structure, land or comer, unless the context otherwise requires.
- 1.03.06 The various restrictions of this by-law are cumulative and not mutually self-exclusive.

Severability

1.03.07 It is declared that if any section, subsection, schedule or part thereof of this by-law be declared by a court of law to be bad, illegal or ultra vires, such part or parts shall be deemed to be severable and all parts hereof are declared to be separate and independent and enacted as such.

Standard Time and Daylight Savings Time

1.03.08 Whenever in this by-law a time of day or hour is referred to, the same shall be construed in accordance with Standard Time or Daylight Saving Time, as may be in current official use in the Town.

Part II

Stopping, Standing and Parking

2.01 Two-way Roadway

- 2.01.01 Where stopping, standing or parking is permitted, except as provided in subsections 2.09 and 2.10, no person shall stop, stand or park any vehicle or permit a vehicle to remain stopped, standing or parked on any roadway where there is a barrier curb or no shoulder on the right side of the roadway, having regard to the direction in which such vehicle was travelling, unless the right front and rear wheels are not more than thirty centimetres (30 cm) from the right curb or edge of the roadway.
- 2.01.02 Where stopping, standing or parking is permitted, except as provided in subsections 2.02.02 and 2.03, no person shall stop, stand or park any vehicle or permit a vehicle to remain stopped, standing or parked

on any roadway where there is shoulder on the right side of the roadway, having regard to the direction in which such vehicle was travelling, unless the right and front wheels parallel to and as near as is practicable to the right edge of the shoulder.

2.02 One-Way Roadway. Left Side

- 2.02.01 Where stopping, standing or parking is permitted on the left side of a highway designated for one-way traffic, except as provided in subsection 2.03, no person shall stop, stand or park any vehicle or permit a vehicle to remain stopped, standing or parked on any roadway where there is a barrier curb or no shoulder on the left side of the roadway, having regard to the direction in which the vehicle was travelling, unless the left front and rear wheels parallel to the left curb or edge of the roadway.
- 2.02.02 Where stopping, standing or parking is permitted on the left side of a highway designated for one-way traffic, except as provided in subsection 2.03, no person shall stop, stand or park any vehicle or permit a vehicle to remain stopped, standing or parked on any roadway where there is a barrier curb or no shoulder on the left side of the roadway, having regard to the direction in which the vehicle was travelling, unless the left front and rear wheels are not more than thirty centimeters (30 cm) away from the left curb or edge of the roadway.
- 2.02.03 Where stopping, standing or parking is permitted on the left side of a highway designated for one-way traffic, except as provided in subsection 2.03, no person shall stop, stand or park any vehicle or permit a vehicle to remain stopped, standing or parked on any roadway where there is a shoulder on the left side of the roadway, having regard to the direction in which the vehicle was travelling, unless the left front and rear wheels parallel to and as near as is practicable to the left curb or edge of the roadway.

2.03 Angle Parking Zones

2.03.01 Where angle parking is permitted, no person shall stop, stand or park any vehicle or permit a vehicle to remain stopped, standing or parked except at the angle designated by signs or markings and with the front end of the vehicle at the curb or the edge of the designated space which is remote from the centre of the roadway.

2.04 Signed or Marked Areas

2.04.01 No person shall permit a vehicle to remain stopped, standing or parked on any portion of any highway designated by signs or markings on the highway for stopping, standing, or parking except when the said vehicle is entirely within the space or area so designated.

2.05 Double Parking Prohibited

2.05.01 No person shall stop, stand or park a vehicle or permit a vehicle to remain stopped, standing or parked on any highway on the roadway side of any stopped, standing or parked vehicle.

2.06 Oversized vehicles, Commercial motor vehicles and Trailers

2.06.01 No person shall park an oversized vehicle, a commercial motor vehicle or a trailer on any Residential Street at any time, except for the purposes of delivery or while such vehicles are being used in conjunction with construction, maintenance or repair which necessitates the parking of the vehicle on the roadway.

2.07 Shoulder and Boulevard Restrictions

2.07.01 Unless otherwise provided in this by-law, no person shall stop, stand or park a vehicle or permit a vehicle to remain stopped, standing or parked on any shoulder or boulevard contrary to the prohibition or restriction applicable to the adjacent roadway as herein provided by this by-law.

2.08 Parking Limitation within the Same Zone

2.08.01 No person shall stop, stand or park a vehicle or permit a vehicle to remain stopped, standing, or parked on a portion of the highway within thirty metres (30 m) of or within one hour from the time of its removal from such portion of a highway where such portion is referred to in Part II to this by-law,

2.09 Stopping Prohibited -Specified Places. Without Signs

- 2.09.01 No person shall stop any vehicle or permit any vehicle to remain stopped on any highway:
- 2.09.01.01 On or partly on or over a sidewalk;
- 2.09.01.02 Within an intersection or crosswalk;
- 2.09.01.03 Adjacent to or across the roadway from any obstruction in the roadway when such action would impede the free flow of traffic;
- 2.09.01.04 Upon any bridge or elevated structure and within any tunnel or underpass, or within thirty metres (30 m) of either end of any such

structure, except where stopping in these locations is otherwise permitted by this by-law;

- 2.09.01.05 On any median strip or adjacent to either side or the ends of any median strip separating two roadways, except when stopping in these locations is otherwise permitted by this by-law;
- 2.09.01.06 On any outer boulevard.
- 2.09.02 Subject to section 2.09 and 2.10, no person shall park an oversized vehicle or permit an oversized vehicle to remain parked on any highway under the jurisdiction of the Town of Grimsby between the hours of 9:00 p.m. and 8:00 a.m.

2.10 Stopping Prohibited -Specified Places. With Sign

- 2.10.01 When official signs are on display, no person shall stop a vehicle or permit a vehicle to remain stopped on a highway:
- 2.10.10.01 within thirty meters (30 m) of the approach side of a crosswalk at a school crossing designated by official signs or of a pedestrian crossover, or within ten meters (10 m) of the remote side of a school crosswalk or a pedestrian crossover;
- 2.10.01.02 within thirty meters (30 m) of the approach side of the nearest rail of any level crossing of a railway or within sixteen meters (16 m) of the remote side of the nearest rail of any such level crossing;
- 2.10.01.03 on either side or both sides of such highway adjacent to a school or playground at such times as displayed on the signs;
- 2.10.01.04 within fifteen meters (15 m) of an intersection;
- 2.10.01.05 within sixty meters (6 0m) of an intersection controlled by a traffic signal
- 2.10.02 When official signs are on display, no person shall stop a vehicle or permit a vehicle to remain stopped on a Municipal Parking Lot as defined in by-law 7 4-12, as amended for a period of time in excess of two (2) hours:

(a) On Monday, Tuesday, Wednesday and Saturday between the hours of 9 am and 6 pm;

(b) On Thursday and Friday between the hours of 9 am and 9 pm.

- 2.10.03 When properly worded signs have been erected and are on display in the parking lots as defined in by-law 79-27, as amended no person shall park:
 - (a) Any Vehicle for a period of time in excess of twenty-four

(24) hours Monday to Friday;

(b) Any Commercial Motor Vehicle having a gross vehicle weight, as registered with the Ontario Ministry of Transportation and Communications, in excess of ³/₄ tonnes.

2.10.04 When properly worded signs have been erected and are on display in the parking lot as defined in by-law 95-90, as amended no person shall park any vehicle for a period of time in excess of two (2) hours on:

(a) Monday, Tuesday, Wednesday, Thursday and Friday between the hours of 9 am and 9 pm; and

(b) Saturday between the hours of 9 am and 6 pm.

2.11 Stopping Prohibited -Schedule "D"

- 2.11.01 When official signs are on display, no person shall stop a vehicle or permit a vehicle to remain stopped on a highway, at the side, between the limits and during the times and days set out respectively in columns 1, 2, 3 and 4 of Schedule "D" of this by-law.
- 2.11.02 The provisions of Subsections 2.10.01.01, 2.10.01.03 or 2.11.01, shall not apply to a school bus within a School Bus Loading Zone designated by official signs.

2.12 Standing Prohibited -Specified Places, With Signs

- 2.12.01 Subject to Section 2.10, when official signs are on display, no person shall stand a vehicle or permit a vehicle to remain standing on a highway:
- 2.12.01.01 within twelve metres (12 m) of the remote side of a designated Transit Commission bus stop or within twenty-eight metres (28 m) of the approach side of such bus stop provided such vehicle does not interfere with a bus waiting to enter or about to enter or exit from such bus stop.

2.13 Standing Prohibited -Schedule "E"

2.13.01 Subject to Section 2.10, when official signs are on display, no person shall stand a vehicle for the purpose of standing or permit a vehicle to remain standing on a highway, at the side, between the limits and during the times and days set out respectively in columns 1, 2, 3 and 4 of Schedule "E" of this by-law.

2.14 Parking Prohibited -Specified Places. Without Signs

- 2.14.01 Subject to Sections 2.10 and 2.11, no person shall park a vehicle or permit a vehicle to remain parked on any highway:
- 2.14.01.02 within ten meters (10 m) of an intersection;
- 2.14.01.03 within three meters (3 m) of a fire hydrant;
- 2.14.01.04 on an inner boulevard;
- 2.14.01.05 on a driveway within thirty centimeters (30 cm) of a sidewalk, between the sidewalk and the roadway or where there is no sidewalk within three meters (3 m) of the edge of roadway or one metre (1 m) of the shoulder;
- 2.14.01.06 in front of or within one and one-half meters (1.5 m) of a laneway or driveway or a curb-cut or depressed curb thereto;
- 2.14.01.07 on either side of a roadway so as to obstruct a vehicle in the use of any laneway or driveway;
- 2.14.01.08 in such a position that will prevent the convenient removal of any other vehicle previously stopped, standing or parked;
- 2.14.01.09 for the purpose of displaying such vehicle for sale or lease;
- 2.14.01.10 for the purpose of servicing or repairing such vehicle except for repairs that have been necessitated by an emergency;
- 2.14.01.11 for a longer period than 16 hours at any one time;
- 2.14.01.12 park at a location prohibited by a Town Engineer where
- 2.14.01.13 park as to interfere with snow removal from highway;
- 2.14.01.14 park as to interfere with street cleaning measures;
- 2.14.01.15 park as to interfere with the movement of traffic;
- 2.14.01.16 no person shall park an oversized vehicle or permit an oversized vehicle to remain parked on any highway under the jurisdiction of the Town of Grimsby between the hours of 9:00 p.m. and 8:00am;

2.15 Parking Prohibited -Specified Places, With Signs

- 2.15.01 Subject to Sections 2.10 and 2.11, when official signs are on display, no person shall park a vehicle or permit a vehicle to remain parked on any highway
- 2.15.01.02 In front of or within eight meters (8 m) of the property limits on which a fire hall is located, or on the opposite side of the said highway, within thirty meters (30 m) of the prolonged lot limits of the said property;
- 2.15.01.03 within twenty-two meters (22 m) of an intersection;
- 2.15.01.04 within forty-five meters (45 m) of an intersection controlled by a traffic signal;
- 2.15.01.05 in front of or within three meters (3 m) of the main entrance to or any emergency exit from any public house, hotel, motel, hospital, nursing home, theatre, auditorium or other building or enclosed space in which persons may be expected to congregate in large numbers;
- 2.15.01.06 within three meters (3 m) of a laneway or driveway or a curb- cut or depressed curb thereto;
- 2.15.01.07 having a roadway width of eight meters (8 m) or less;
- 2.15.01.08 within thirty meters (30 m) of the approach side and within fifteen meters (15 m) of the remote side of a crosswalk controlled by a traffic signal and not located at an intersection;
- 2.15.01.09 so as to interfere with the formation of a funeral procession;
- 2.15.01.10 within the turning circle or basin of a cul-de-sac;
- 2.15.01.11 within fifteen meters (15 m) of the termination of a dead end roadway;
- 2.15.01.12 where the Chief of Police or Traffic Co-Ordinator is of the opinion that, for some temporary period, the safety of the public, the proper movement of traffic, or the proper and safe performance of some vital function of the Town requires the prohibition or limitation of

parking;

2.15.01.13 within fifteen meters (15 m) either side of Canada Post community mailbox opening to and access from the road side at all times;

2.16 Parking Prohibited -Schedule "F"

2.16.01 Subject to Sections 2.10 and 2.11, when official signs are on display, no person shall park a vehicle or permit a vehicle to remain parked on a highway, at the side, between the limits and during the times and days set out respectively in columns 1, 2, 3 and 4 of Schedule "F" of this by-law.

2.17 Trailer and Commercial Motor Vehicle Parking Prohibition-Schedule "G"

2.17.01 Subject to Sections 2.10 and 2.11 when official signs are on display, no person shall park a trailer or commercial motor vehicle, or permit a trailer or commercial motor vehicle having a registered gross vehicle weight in excess of that shown in Column 5 of Schedule "G" of this by-law to remain parked on a highway, at the side, between the limits and during the times and days set out respectively in columns 1, 2, 3 and 4 of the said Schedule "G".

2.18 Parking Restriction Exemptions -Funeral Cortege

2.18.01 If the Chief of Police is of the opinion or deems it desirable, he may declare that Subsections 2.15.01.04, 2.15.01.05, 2.15.01.08 and 2.16 do not apply for a temporary period to prevent the parking of vehicles forming part of any funeral cortege, provided that all such vehicles are parked on only one side of the highway at one time.

2.19 Limited Parking-Schedule "H"

2.19.01 Subject to the previous sections of Part II, when official signs are on display, no person shall park a vehicle or permit a vehicle to remain parked on a highway, at the side, between the limits, for a longer period of time and during the times and days set out respectively in columns 1, 2, 3, 4 and 5 of Schedule "H" of this bylaw.

2.20 Angle Parking -Schedule "I"

2.20.01 Subject to the previous sections of Part II, angle parking is permitted on the roadways, at the sides and between the limits set forth respectively in columns 1, 2 and 3 of Schedule "I" of this by-law.

2.21 Parking Meters -General Regulations

- 2.21.01 Where parking meters have been installed under the authority of this by-law, no person shall park a vehicle or permit a vehicle to remain parked in a parking meter space unless:
- 2.21.01.01 Where parallel parking is permitted, the front wheels of such vehicle are adjacent to the single parking meter provided for such parking meter space;
- 2.21.01.02 Where parallel parking is permitted and two meters are mounted on the same standard, the rear wheels of the remote vehicle shall be adjacent to or as close as is practicable to such parking meters and the front wheels of the approach vehicle shall be adjacent to or as close as is practicable to such parking meters;
- 2.21.01.03 where angle parking is permitted, the front wheels of the vehicle shall be adjacent to or as close as is practicable to the parking meter provided for such parking meter space.
- 2.21.02 No person shall park a vehicle or permit a vehicle to remain parked in such a manner that it is not wholly within the area designated as a parking space unless the vehicle is of such length as to render it impossible to park it in one parking space, in which case the adjoining parking space or spaces may, in addition, be used if the required coin deposits are made in the parking meters provided for all such parking spaces so used.
- 2.21.03 No person shall park a vehicle or permit a vehicle to remain parked in a parking meter space if:
- 2.21.03.01 the parking meter has been covered by a parking meter cover or parking prohibition sign, or
- 2.21.03.02 such parking meter space is presently occupied by another vehicle.

2.22 Parking Metered Space subject To Other Provisions

2.22.01 The stopping, standing and parking of vehicles in metered spaces shall be subject to all prohibitions, restrictions, limitations and provisions of this By-law, other Town Traffic By-laws and The Highway Traffic Act.

2.23 Use of Parking Meter

- 2.23.01 No person shall deposit or cause to be deposited in any parking meter
- 2.23.02 such parking meter space is presently occupied by another vehicle.

2.22 Parking Metered Space Subject to Other Provisions

2.22.01 The stopping, standing and parking of vehicles in metered spaces shall be subject to all prohibitions, restrictions, limitations and provisions of this By-law, other Town Traffic By-laws and The Highway Traffic Act.

2.23 Use of Parking Meter

- 2.23.01 No person shall deposit or cause to be deposited in any parking meter:
- 2.23.01.01 any slug, device or other substitute for a coin of the Dominion of Canada or of the United States of America,
- 2.23.01.02 Any coin except a one cent coin, also referred to as a "penny", a five-cent coin commonly referred to as a "nickel", a ten-cent coin commonly referred to as a "dime", a twenty-five-cent coin commonly referred to as a "quarter", or a dollar coin commonly referred to as a "dollar", of the Dominion of Canada or of the United States of America.

2.24 Parking Meter Zones-Schedule "J"

- 2.24.01 The highways or portions of the highways described in Schedule "J" of this by-law are hereby designated as parking meter zones.
- 2.24.02 Subject to the provisions in Subsection 2.24.01, when parking meters have been erected on the highway, at the side and between the limits set out respectively in columns 1, 2 and 3 of Schedule "J" of this by-law, no person shall park a vehicle or permit a vehicle to remain parked for a longer period of time and during the times and days set out respectively in columns 5 and 6 of the said schedule.
- 2.24.03 Subject to the maximum parking time period and the hours and days of operation set out in Schedule "J" of this by-law, no person shall park any vehicle or permit a vehicle to remain parked in a parking meter space unless the fee set out in column 4 of the said

schedule is deposited in the meter controlling such parking meter space and the said meter is in operation.

2.25 Unexpired Parking Meter

2.25.01 The driver of a vehicle shall not be prevented from using the unexpired time remaining on a parking meter from its previous user without depositing a coin therefor.

2.26 Vehicle at Expired Parking Meter

- 2.26.01 No person shall park a vehicle or permit a vehicle to remain in a parking meter space where the time has expired.
- 2.27 Section Reserved

Part III

Special Zones

3.01 Bus Stops

3.01.01 The establishment of a bus stop for local Transit Commission buses on roadways is hereby authorized and shall be conclusively deemed to have been established when official signs are on display.

3.02 Public Vehicle (Inter-City) Parking Zone -Schedule "K"

3.02.01 Subject to Part II, when official signs are on display, no person shall park a vehicle or permit a vehicle to remain parked on the highway, at the side, between the limits and during the times and days set out respectively in columns 1, 2: 3 and 4 of Schedule "K" of this by-law, except a public vehicle.

3.03 Public Vehicle (Inter-City) Bus Stop -Schedule "L"

3.03.01 Subject to Part II, when official signs are on display, no person shall stand a vehicle or permit a vehicle to remain standing on a highway, at the side, between the limits and during the times and days set out respectively in columns 1, 2, 3 and 4 of Schedule "L" to this by-law, other than a public vehicle taking on or discharging passengers except that the driver of a vehicle may temporarily stop in a bus stop for the purpose of and while actually engaged in loading or unloading passengers when such stopping does not interfere with a public vehicle waiting to enter or about to enter or exit such bus stop.

3.04 School Bus Loading Zones

3.04.01 When official signs have been erected in accordance with The Highway Traffic Act the portion of highway designated by such signs is hereby established as a "School Bus Loading Zone" and subject to the regulation under the said Act.

3.05 Vending Stops -Schedule "M"

- 3.05.01 No person who sells or offers for sale or takes orders for goods, wares, merchandise or produce from a vehicle shall, for the purpose of carrying on their business, stop the vehicle or permit the vehicle to remain stopped on any part of the highway in such a manner as to interfere with the movement of traffic.
- 3.05.02 No person shall offer for sale or take orders for goods, wares, merchandise or produce from a vehicle on a highway except from the side of such vehicle facing the closest boulevard.
- 3.05.03 Subject to Part II, no person shall stop a mobile canteen on a roadway, at the side, between the limits and during the times and days set out respectively in columns 1, 2, 3 and 4 of Schedule "M" of this by-law.

3.06 Taxi Cab Stands -Schedule "N"

3.06.01 Subject to Part II, when official signs are on display, no person shall stand a vehicle or permit a vehicle to remain standing on the highway at the side, between the limits and during the times and days set out respectively in columns 1, 2, 3 and 4 of Schedule "N" of this by-law, except a taxi cab.

3.07 Loading Prohibited -Schedule "0"

3.07.01 Subject to Part II, when official signs are on display, no person shall stop a vehicle to load or unload freight or merchandise or permit a vehicle to stop to load or unload freight or merchandise on a highway, between the limits, at the side and during the times and days set out respectively in columns 1, 2, 3 and 4 of Schedule "O" of this by-law.

3.08 Loading Zones -Schedule "P"

3.08.01 Subject to Part II and previous sections of Part III, when official signs are on display, no person shall stop a vehicle or permit a vehicle to remain stopped on a highway, between the limits, at the

side and during the times and days set out respectively in columns 1, 2, 3 and 4 of Schedule "P" of this by-law, except a commercial motor vehicle when parked temporarily for the purpose of and while actually engaged in loading or unloading freight or merchandise and such parking shall not exceed a period of thirty (30) minutes.

3.09 Parking in Fire Routes

- 3.09.01 No person shall park a vehicle in any private roadway designated as a fire route at any time, except for authorized emergency vehicles;
- 3.09.02 Fire routes shall be kept clear of any obstruction likely to prevent or restrict access at all times.
- 3.09.03 No person shall fail or refuse to comply with any lawful notice, order or direction with respect to a fire route, given by the Fire Chief or a Police Officer and any such failure or refusal shall constitute an offence under this by-law.
- 3.09.04 No person shall remove, deface, cover or alter any sign designating a fire route.

3.10 Parking in Physically Disabled Parking Spaces

- 3.10.01 Subject to Sections 2.10 and 2.11, when official signs are on display no person shall park an unauthorized vehicle in a designated parking space;
- 3.10.02 No person, other than a physically disabled person who is the operator of a vehicle or a person who is the operator of a vehicle that is carrying a physically disabled person and displaying a valid permit shall use a designated parking space;
- 3.10.03 The driver of a vehicle, not being the owner, is liable to any penalty provided under this by-law and the owner of the vehicle is also liable to such penalty unless, at the time of the offence the vehicle was in the possession of a person other than the owner or his chauffeur, without the consent of the owner.

Part IV

Erection of signs

4.01 Authorization

4.01.01 The Director of Public Works is hereby authorized to apply, erect and maintain such traffic control devices and other structure, plant and equipment as required giving effect to this by-law.

4.02 Conflicting Private Signs

- 4.02.01 Subject to the provisions of other by-laws controlling signs, no unauthorized person shall place, maintain or display upon any sign, signal, marking, or device visible from any highway which:
- 4.02.01.01 conceals a traffic control device or parking meter from view;
- 4.02.01.02 interferes with the effectiveness of a traffic control device or parking meter; or
- 4.02.01.03 purports to be, is an imitation of, or resembles any official sign or any regulatory or traffic control device.

4.03 Damage to Traffic Control Devices

- 4.03.01 No person shall move, deface, damage, remove, or in any manner interfere with any traffic control device placed, erected or maintained by the Town.
- 4.03.02 No person shall drive any vehicle on or over any pavement marking, line or strip on the roadway where markers are in place, or signs are on display to indicate that the marking material has been freshly applied, nor shall any person drive any vehicle into or over any such marker so placed, or move or remove such marker unless authorized to do so.

PART V

Offences and penalties

- 5.01 Subject to the Town's Administrative Monetary Penalty System and the Provincial Offences Act
- 5.01.01 Any person who contravenes a provision of this by-law is guilty of an offence and upon conviction, is liable to the penalties provided for in the Provincial Offences Act and to any other applicable penalties.

5.02 Offences Punishable by the Highway Traffic Act

5.02.01 Any person who contravenes any section of this by-law for which a penalty is provided by The Highway Traffic Act is subject to such penalties.

5.03 Voluntary Penalties -Schedule "B"

5.03.01 Any person who contravenes any of the prov1s1ons of the sections or subsections of this by-law set out in column 2 of Schedule "B" of this by-law and wishes to make a voluntary payment pursuant to the by-law, may pay the amount set out in column 3 of the said schedule, such amount to be payable in lawful money of Canada and all such penalties are exclusive of costs.

5.04 General Penalty

- 5.04.01 Each person who permits a vehicle to be parked, standing or stopped contrary to a part of this by-law and each owner of that vehicle are, when given a Penalty Notice in accordance with this bylaw, liable to pay to the Town an Administrative Penalty in the amount specified in Schedule "B" and "C" to this by-law for which day or part of a day on which the contravention continues. 5.05 Validity
- 5.05.01 Should a court of competent jurisdiction declare a part or whole of any provision of this by-law to be invalid or of no force and effect, the provision or part is deemed severable from this by-law and it is the intention of Council that the remainder survive and be applied and enforced unless the Court makes an order to the contrary.

5.06 Exemptions - Municipal Vehicles

- 5.06.01 The provisions of Parts II and III of this by-law, except Section 2.21 to 2.26 thereof, do not apply to:
- 5.06.01.01 Vehicles operated by or on behalf of the Town, The Regional Municipality, or any municipal utility while engaged in the performance of cleaning, clearing, maintenance, repair, construction or other work on any highway;
- 5.06.01.02 Vehicles operated by or on behalf of the Town or the Regional Municipality while on official business.
- 5.06.01.03 Parts II and III of this by-law shall not, m the case of emergency, apply to an emergency vehicle.

Part VI

Administration, application and enforcement

6.01 Administration

6.01.01 The administration of this by-law that applies to Ontario Regulation 333/07 and may designate other by-laws to be applicable to the administrative penalty system established through this By-law are set out in Schedules "A", "B" and "C".

6.02 Application of By-law

- 6.02.01 This by-law applies to all highways and parts of highways under the jurisdiction of the Town.
- 6.02.02 This by-law applies to those contraventions of the provisions creating or defining offences identified in Schedule "B" to this by-law and included in the by-law Designated Parking Spaces for the Sole Use of Vehicles Operated by or Conveying a Physically Handicapped Person, 93-35 as amended; Designated Fire Routes on Certain Lands and Properties, 80-20 as amended; Designated By-law Provisions Municipal Parking Lot 74-12, 79-27 and 95-90 as amended.

6.03 Enforcement

- 6.03.01 This by-law shall be enforced by the Police Force and by any officer appointed for the enforcing or carrying out of the provisions of this by-law.
- 6.03.02 An Officer, upon discovery of any vehicle parked or standing in contravention of this by-law of any vehicle apparently abandoned or of any vehicle without proper number plates on a highway, may cause such vehicle to be moved or taken to and placed or stored in a suitable place and all costs and charges for removing, care and storage thereof, if any, are a lien upon such vehicle, which may be enforced in the same manner provided in the Mechanics' Lien Act.

6.04 By-law Subject to The Highway Traffic Act

6.04.01 The provisions of this by-law are subject to the provisions of The Highway Traffic Act.

6.05 Schedules Adopted

6.05.01 The Schedules referred to in this by-law shall form part of this bylaw and each entry in a column of such a schedule shall be read m conjunction with the entry or entries across therefrom and not otherwise.

6.06 Former By-laws Repealed

Schedule A to By-law 16-82

Administration

Penalty Notice

- Every Person who contravenes a provision of a Designated By-law shall, 1. when given a Penalty Notice, be liable to pay to the Town an Administrative Penalty in the amount specified in Schedule "B" and "C".
- 2. An Officer who has reason to believe that a Person has contravened a provision of a Designated By-law may issue a Penalty Notice to that

Person.

- 3. A Penalty Notice shall include the following information:
- a. the vehicle license plate number or vehicle identification number;
- b. the Penalty Notice Date;
- c. a number that is unique to the Penalty Notice;
- d. the contravention wording listed in Schedule " B" and "C", which describes particulars of the contravention;
 - e. the amount of the Administrative Penalty;
- f. such information as the Director determines is appropriate respecting the process by which the Person may exercise the Person's right to request a review of the Administrative penalty; and
- g. a statement advising that an Administrative Penalty, including any
 Administrative Fee, will, unless cancelled or reduced pursuant to a review,
 constitute a debt of the Person to the Town.
- 4. A Person who is given a Penalty Notice and who does not pay the amount of the Administrative Penalty within a minimum of 15 days of the Penalty Notice Date may pay to the Town an MTO Search Fee and any other applicable penalties, such amount to be payable in lawful money of Canada.

Review by a Screening Officer

- 5. A Person who is given a Penalty Notice may request that the Administrative Penalty be reviewed by a Screening Officer and shall do so within 15 days after the Penalty Notice Date or within the extension period granted by the Screening Officer where the Person demonstrates, on a balance of probabilities, the existence of extenuating circumstances that want the extension;
- 6. A Person's right to request an extension of time expires if it has not been exercised within the time limit set out in section 8 at which time:
- a. the Person shall be deemed to have waived the right to request a review;
- b. the Administrative Penalty shall be deemed to be affirmed on the day after the Extension Period has passed if granted, and
- c. the Administrative Penalty shall not be subject to any further review, including review by any Court.
- 7. A Person's right to request a review or to request an extension of time are exercised by:
- a. Submitting a Request for Screening or extension form available at the Town's web page as set out in the Penalty Notice by mail, fax or email and scheduling the time and place for the review; or
- b. Attending in person at the location listed in the Penalty Notice to complete a

Request for Screening or extension form and scheduling the time and place for review.

- 8. A review or request for an extension of time for review shall only be scheduled by the Town if the Person has exercised his or her right to request a review or an extension for review within the time limits set out in sections 7.
- 9. Where a Person fails to attend at the time and place scheduled for a review of the Administrative Penalty by the Screening Officer:
- a. the Person shall be deemed to have abandoned the request for a review of the Administrative Penalty;
- b. the Administrative Penalty as set out in the Penalty Notice shall be deemed to be affirmed on the 16th day after the Penalty Notice and is not subject to any further review, including by any Court; and
- c. the Person shall pay to the Town a Screening Non-appearance Fee.
- 10. On review of the Administrative Penalty, the Screening Officer may affirm the Administrative Penalty, or the Screening Officer may cancel, vary or extend the time for payment of the Administrative Penalty, including any Administrative Fee, on the following grounds:
- a. where the Person establishes on a balance of probabilities, that he or she did not contravene the Designated By-law as described in the Penalty Notice; or
- b. where the Person establishes on a balance of probabilities that the reduction or extension of time for payment of the Administrative Penalty, including any Administrative Fee, is necessary to relieve any undue hardship.
- 11. After a review has been held, the Screening Officer shall deliver a Screening Decision to the Person.

Review by a Hearing Officer

- 12. A Person may request a review of a Screening Decision by a Hearing Officer and shall do so within 15 days after the Screening Decision has been delivered to the Person.
- 13. A Person's right to request a review or extension expires if it has not been exercised within 15 days after the Screening Decision has been delivered at which time:
- a. the Person shall be deemed to have waived the right to request a hearing;
- b. the Screening Decision and the Administrative Penalty, if applicable as modified in the Screening Decision, shall be deemed to be affirmed on the

16th day after the Screening Decision has been delivered or the Extension Period has passed; and

- c. the Screening Decision and the Administrative Penalty shall not be subject to any further review, including review by any Court.
- 14. A Person's right to request a review of a Screening Decision or to request an extension of time are exercised by:
- a. Submitting a Request for Review or extension by Hearing Officer form available at the Town's web page as set out in the Screening Decision by mail, fax or email; or
 - b. Attending in person at the location listed in the Screening Decision to complete a Request for Review or extension by Hearing Officer and filing a completed form.
- 15. Where a Person fails to attend at the time and place scheduled for a review by the Hearing Officer:
- a. the Person shall be deemed to have abandoned the request for a review of the Screening Decision;
- b. the Screening Decision and Administrative Penalty, if applicable as modified in the Screening Decision, shall be deemed to be final and are not subject to any further review, including by any Court;
- c. the Administrative Penalty, if applicable as modified in the Screening Decision, shall be deemed to be affirmed on the date the Screening Decision was delivered to the Person; and
- d. the Person shall pay to the Town a Hearing Non-appearance Fee.
- 16. A Hearing Officer shall not make any decision respecting a review of a Screening Decision unless the Hearing Officer has given the Person and the Town an opportunity to be heard at the time and place scheduled for the hearing of the review.
- 17. On review of a Screening Decision, the Hearing Officer may affirm the Screening Decision, or the Hearing Officer may cancel, vary or extend the time for payment of the Administrative Penalty, including any Administrative Fee, on the following grounds:
- a. where the Person establishes a balance of probabilities, that he or she did not contravene the Designated By-law as described in the Penalty Notice; or
- b. where the Person establishes on a balance of probabilities, that the reduction or extension of time for payment of the Administrative Penalty including any Administrative Fee, is necessary to relieve any undue hardship.
- 18. All hearings conducted by the Hearing Officer shall be in accordance with the Statutory Powers and Procedures Act, R.S.O. 1990, c. S.22, as amended.

- 19. After a hearing is completed, the Hearing Officer shall issue to the Person a Hearing Decision.
- 20. Any decision by a Hearing Officer is final.
- 21. Neither a Screening Officer nor a Hearing Officer has jurisdiction to consider questions relating to the validity of a statute, regulation or By-law or the constitutional applicability or operability of any statute, regulation or By-law.

Service of Documents

- 22. (1) Service of any document or notice, including a Penalty Notice, respecting this By-law may be given in writing in any of the following ways and is effective;
 - a. affixing it to the vehicle in a conspicuous place at the time of the violation;
 - delivering it personally to the operator of the vehicle or the person in care and control of the vehicle at the time of the contravention;
 - c. when a copy is delivered to the Person to whom it is address;
 - d. on the fifth day after a copy is sent by registered mail or by regular letter mail to the Owner's last known address;
 - e. upon the conclusion of the transmission of a copy by facsimile transmission to the Person's last know facsimile transmission number; or
 - f. upon the sending a copy by e-mail transmission to the Person's last known email address.
 - (2) For the purpose of subsection 22(1)(b), (c), (d), a Person's last known address, facsimile number and e-mail address may include an address, facsimile number and e-mail provided by the Person to the Town as may be required by a form, practice or policy developed under this By-law.

Administration of the By-law

- 23. The Director shall administer the By-law and establish any practices, policies and procedures necessary to implement the By-law and may amend such practices, policies and procedures from time to time as the Director deems necessary.
 - 24. The Director shall prescribe all forms and notices, including the Penalty Notices, necessary to implement the By-law and may amend such forms and notices from time to item as the Director deems necessary.
 - 25. The Director may designate areas and locations for conducting Screening Reviews and Hearings under this By-law.

General Provisions

- 26. An Administrative Penalty, including any Administrative Fees, that is affirmed or reduced or in respect of which the time for payment has been extended is due and payable and constitutes a debt to the Town owned by the Person to whom the Penalty Notice was given.
- 27. Where an Administrative Penalty is not paid within a minimum of 15 days after it becomes due and payable, the person to whom the Penalty Notice was given shall pay to the Town a Late Payment Fee.
- 28. Where and Administrative Penalty is not paid within 30 days after it become due and payable, the Town shall notify the Registrar of Motor Vehicles of the default and the Registrar shall not validate the permit of a person named in the default notice nor issue a new permit to that person until the penalty is paid.
- 29. Where an Administrative Penalty or any administrative fees respecting that Administrative Penalty are not paid within thirty 30 days after the date that they become due and payable, each Person to whom the Penalty Notice was given shall pay to the Town a MTO Plate Denial Fee.
- 30. Where a person provides a demand for payment to the Town for payment of any Administrative Penalty or Administrative Fee, which has insufficient funds available in the account on which the instrument was drawn, shall pay to the Town a NSF Fee as specified in Schedule "C".
- 31. Where an Administrative Penalty is cancelled by a Screening Officer or a Hearing Officer, any Administrative Fee is also cancelled.
- 32. Any time limit that would otherwise expire on a Holiday is extended to the next day that is not a Holiday.
- 33. No Officer may accept payment in respect of an Administrative Penalty.
- 34. Any schedule attached to this By-law forms part of this By-law.


