

NOTICE

PASSING OF MUNICIPAL-WIDE DEVELOPMENT CHARGES BY-LAW

TAKE NOTICE that the Council of the Corporation of the Town of Grimsby passed municipal-wide Development Charges By-law No. 2022-17 on the 21st day of March, 2022 under Section 2 (1) of the *Development Charges Act, 1997, S.O., 1997 c. 27*, as amended;

AND TAKE NOTICE that any person or organization may appeal to the Local Planning Appeal Tribunal under section 14 of the Act, in respect of the Development Charges By-law, by filing with the Clerk of the Corporation of the Town of Grimsby on or before the 20th day of May, 2022 a notice of appeal setting out the objection to the By-law and the reasons supporting the objection.

The schedule of development charges imposed by the By-law, which came into effect on March 21, 2022, being in 2020 dollars rates, indexed to 2022 dollars, is as follows:
